

TERMS AND CONDITIONS OF TRAINING CONDUCTED BY LUS.EXPERT.TRAINING refers to the course entitled "Lung Ultrasound with elements of echocardiography and interventional diagnostic", 16-18.06.2019.

I Regulations of the course organized by LUS.expert.training

- 1. Training in ultrasound, entitled ""Lung Ultrasound with elements of echocardiography and interventional diagnostic" is organized by ISPL Natalia Buda, ul. Lecha Kaczyńskiego 24/87, 80-365 Gdańsk, in Poland, hereinafter referred to as LUS.Expert.training or organizer, as well as us, us, ours. In all matters relating to training please contact us by the following email address: training@lus.expert.
- 2. The teaching director of the LUS.expert.training is PhD Natalia Buda
- 3. The training entitled ""Lung Ultrasound with elements of echocardiography and interventional diagnostic" is dedicated to physicians during specialization and specialists in internal medicine, pulmonology, emergency medicine, intensivists and students of the medical department and sonographers.
- 4. The training is entirely conducted in English.
- 5. The course covers a total of 25 training hours of classes, including 8 practical classes and 17 hours of theoretical classes.
- 6. Practical classes are conducted in two-person groups (2 participants at the ultrasound machine).
- 7. The training is completed with a test verifying the degree of knowledge and skills acquired during the current course.
- 8. After the training, the student receives a certificate.
- 9. The condition for obtaining a certificate of participation in the course is:
 - a. presence in theoretical and practical classes
 - b. active participation in classes
 - c. self-testing of ultrasound exam
 - d. passing the final test, single choice (minimum 60% of correct answers)
 - e. payment of the full course fee
- 10. Training is approved by the Regional Medical Chamber in Gdańsk, which grants 13 educational points (Journal of Laws 04.231.2326)

II Place, date, hours and costs of the training

- 1. Lectures and practical classes will be realized in one building at the Qubus hotel, ul. Chmielna 47-52, 80-748 Gdańsk.
- 2. Lunch and coffee breaks are scheduled for each day of the training. The first day of the training also includes dinner for the participants of the course.
- 3. The course begins at 8.30 on 16/06/2019 and ends at 19.00 on 18/06/2019.
- 4. The total cost of the course is 2000 EUR (gross). The comprehensive training service includes: substantive and practical parts, lunch, coffee breaks and educational materials (an annual license to the LUS.expert portal and the Lung Ultrasound Atlas of Cases hard cover book).
- 5. Lus.expert.training reserves the right to cancel the course no later than 6 weeks before the planned date of the start of the course in the event that there is no sufficient number of participants registered or for other reasons not attributed to the organiser. The minimum number of participants is 80% persons. Please be informed that if you make any travel arrangement before the term specified above, the organiser will not be liable for any costs incurred by you in case the course is cancelled.
- 6. The organizer reserves the right to change the place of the training within the same city, no later than 10 days before the planned date of commencement of the course. Such change shall not influent on the original course conditions offered to our clients as well as increase of the product price.
- 7. Participants are not entitled to record image or sound during the course.
- 8. Lus.expert.training is not responsible for obtaining a visa or any other permits for participants from outside the country where the training is taking place. This is the sole responsibility of each participant.



III. Rules of payment for ordered LUS.expert trainings

2. The organizer reserves the right to provide other forms of payment than those mentioned in point 1, based on individual arrangements with the User.

IV. Personal data security policy

- 1. Lus.expert.training obeys the following legal regulations: Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (General Data Protection Regulation), and currently applicable national law, in particular Polish Act on the Protection of Personal Data of 10 of May 2018 (Journal of Laws of 2018 item 1000).
- 2. The lus.expert.training is the administrator of personal data of all participants. Personal data shall be proceeded for the purpose of executing agreements with the Customers on participation in the trainings The legal basis for such processing is the article 6 par. 1 lit. b of the General Data Protection Regulation processing is necessary for execution of the agreement concluded with the customer. V. Withdrawal

- 1. Subject to the point 2 below, the customer has the right to withdraw from the agreement with lus.expert.training within 14 days from the date of entering into the agreement, without giving a reason. Withdrawal from the agreement takes place by submitting a statement. The statement can be submitted in the sample form available https://lus.expert/bundles/app/images/guide/courses/1/withdrawal.pdf. It is not mandatory to use sample provided. The declaration may be submitted in electronic form to the following email address lus.expert.training: training@lus.expert. Lus.expert.training will promptly confirm receipt of the statement of withdrawal.
- 2. By concluding an agreement with lus.expert.training in regard to participation in the training course, which is to start before the expiry of the 14-day deadline for withdrawal from the agreement, the Customer consents to start the agreement before the expiry of the above-



mentioned deadline. In this case, the customer is obliged to pay for the services fulfilled by lus.expert.training until withdrawal from the agreement. If the service was performed by lus.expert.training in its entirety before the expiry of the above-mentioned deadline, the customer loses the right to withdraw from the agreement.
